Context:

Since this is a co-ed college, the parents of the female students are worried about the safety of their wards, \.By informing the parents on a daily basis, the anxiety of the parents would be quelled .At the same time, the presence of their wards in the college is confirmed.

Evidence of success: Now parents call up the institution as and when they get the SMS regarding the absence of their wards.

Result: Absenteeism has been considerably reduced thereby the academic performance of the students has improved.

Best Practice 2: Strengthening of the exam cell

Goal:

Ensuring transparency and avoiding malpractices

Context:

As the institution plans to seek autonomous status, an exam cell has been created as in the case of universities Separate staff members have been appointed for the purpose.

Practice:

Separate guidelines for the conduct of the internal tests and model exam have been prepared. Covering the procedure for setting up of question papers, conduct of examinations and evaluation of answer scripts. An academic calendar which specifies the date and duration of internal tests and model examinations is distributed to the members of the staff at the beginning of the academic year itself. As per the schedule given in the academic calendar, the question papers are prepared by the members of the staff in advance and copies are made ready. The internal tests and model examinations are conducted in a centralized manner as per the calendar. Besides, answer scripts are valued on the very day of the examination. Marks are intimated to the parents within three days from the date of examinations.

Evidence of success:

The question papers for the internal tests and model examinations are set on a single day in a centralised fashion.

Result:

The internal tests and model examinations are conducted smoothly .This helps the exam cell to conduct the university examinations in a very effective manner.
